## (World Athletics E category competition)

(Jelgava City Championships, COACH ULDIS SAMSONS MEMORIAL CUP)

#### 1. The aim

To promote and develop track and field in Latvia.

#### 2. Time and place

#### **Competition venue:**

Zemgale Olympic centre Janis Lusis stadium (Kronvalda street 24, Jelgava).

**Date:** 05.06.2021.

**Start of competition:** 12:00

## 3. Participants/ age groups

- **3.1.** Only national team athletes are allowed to participate. Confirmations from National Athletics federations are required.
- **3.2.** Age groups:
  - U18 2004-2005;
  - Joint group: adults 1998 and older, U23 1999-2001, U20 2002-2003.







### 4. Applications

- 4.1. Application period: 24.05.2021. 12:00 31.05.2021. 12:00.

### **5. Competition disciplines**

- **5.1.** U18: 100m, 400m, 1500m, 400m/h, long jump, shot put, discus throw.
- **5.2.** Joint group: 200m, 400m, 800m, 3000m, 400m/h, long jump, high jump, pole vault, shot put\*, discus throw\*.
- **5.3.** If the discipline is not included in U18 age group program, U18 athletes are allowed to compete in Joint group.
  - \* In a Joint group U20 athletes can compete with U20 age group implements but out of competition.

### 6. Participation fee

- **6.1.** To participate in the competions, athletes must pay 5.00EUR fee.
- **6.2.** Participation fee has to be paid until competion to following bank account:

#### **GENERAL TERMS**

#### 7. Clothing

- **7.1.** Participants are allowed to compete in track and field uniforms.
- **7.2.** Participants are prohibited to compete in National team uniforms.

#### 8. Bibs

Competition bibs must be worn as issued and may not be cut, folded or obscured in any way. No athlete shall be allowed to take part in competition without displaying the appropriate bib.

#### 9. Call room

- **9.1.** Call room schedule will be available on the competition site.
- **9.2.** A participant who has not registered at the call room or arrives at the sector of the competition independently will not be admitted to the start.







### **10.** Award ceremony

- **10.1.** Competion is held according to World athletics competition rules.
- **10.2.** Each discipline winner (1st place) will be awarded with a competition cup and Sportland gift card.
- **10.3.** Jelgava City championships winners (1st 3rd place) will be awarded with medals and organizers' gifts.
- **10.4.** Award ceremony will be held in accordance with a competion program.
- **10.5.** If an athlete does not attend award ceremony, athlete will be disqualified from the competition.

### 11. Competition results

- **11.1.** Competition results will be available online: <a href="https://www.athletics.lv">www.athletics.lv</a>.
- **11.2.** During competion printed results will be available on the competition site.

## 12. Doping control

Doping control may be conducted.

#### 13. Medical services

- **13.1.** Athletes themselves or organization they represent are responsible for each participant's health.
- **13.2.** During competition, organizers provide first aid for athletes.
- **13.3.** The main responsible person for Covid-19 safety measures: Agnese Kalnina.

#### 14. Protests

- **14.1.** Any protests will be considered in accordance with Rule 146 of the World Athletics Technical Rules.
- **14.2.** Protests concerning the result or conduct of an event shall be made within 30 minutes of the official announcement of the result of that event. It shall be in writing, signed by the athlete, by someone acting on their behalf or by an official representative of a team and shall be accompanied by a deposit of EUR 30.

#### 15. Financial conditions

Participant travels, board and lodging are paid by participants or their organization.







# 16. Protection of personal data

## 17. COVID- 19 control measures

- **17.1.** Competition organizers, participants, coaches and other support staff must comply with the regulations of the Cabinet of Ministers No. 360 "Epidemiological Safety Measures for the Containment of the Spread of COVID-19 Infection".
- **17.2.** Foreign athletes must present a certificate of a negative COVID-19 test performed no later than within the last 72 hours to the competition secretariat.
